Subject: Regarding concessions offered by the Max Super Speciality Hospital, Mohali to PSPCL employees/pensioners/family pensioners and their dependents.

The Max Super Speciality Hospital, Near Civil Hospital, Phase-6 Mohali has agreed to provide the following concessions to the employee/pensioners/family pensioners and their dependents:

1. **Offer Rates as per Current CGHS NABH -2014 Rates** (who are not covered under any insurance) for following only:-
 - a. Cardiac Sciences (Cardiology and Cardiovascular and thoracic Surgery)
 - b. Joint Replacement/Orthopaedics Surgeries made under Orthopaedics.
 - c. Oncology Services.
 - d. Renal Transplant Services.
2. **Other Mutispecialty Services** -(who are not covered under any insurance) a discount of 10 % on package excluding Drugs, Consumables, Pharmacy and investigations (Maximum up to Rs. 10,000/-) will be given. In case a package is not available for a particular speciality or a disease, 10% discount on procedure/Surgery charges and on non-ICU room rents will be given on Max tariff.
3. **OPD and Diagnostics:** A discount of 10% shall be imparted on consultation and diagnostics. However no discount on Send Outs/Out-sourced Services.
4. **Annual Health Check-Up.** A special discount of 20% on existing Max health packages

In view of the offer given by the hospital, this office is of the view that the offer of the hospital may be considered subject to following conditions:-

- i) PSPCL will sign no agreement with the hospital in this regard.
- ii) The beneficiaries i.e. PSPCL employees/pensioners/family pensioners and their dependents are advised to equip themselves with full knowledge of hospital rules/rates/conditions before availing services as PSPCL is only circulating the offer of concessions given by the hospital and will not give any clarification or attend any complaint in this regard.
- iii) PSPCL will not binding any employee/pensioner/family pensioners and their dependents to get the treatment from their hospital.
- iv) Payment of OPD and IPD will be made directly to the hospital by the employee/ pensioner and their dependents. However the employee/ pensioner/family pensioner, if entitled to get reimbursement, can claim re-imburement from PSPCL as per prevailing instructions and at the rates/ amount verified by the Health department wherever applicable.

- vi) The tenure of this concession will be for a period of one year from the date of issue of the letter. However the hospital can stop giving the above mentioned concession by giving one month notice in writing to PSPCL.
- vii) The beneficiary must produce the PSPCL Identity Card at the time of taking any service at OPD/IPD.
- viii) In case of patient taking cashless treatment through Insurance or TPA then above mentioned discount or special rate is not applicable to him/her or their beneficiary.
