**Subject: Regarding concessions offered by the Sangha Hospital, Ropar to PSPCL employees/pensioners/family pensioners and their dependents.**

The Sangha Hospital, Zail Singh Nagar, Radha Swami Satsang Bhawan, Ropar has agreed to provide the following concessions to the employee/pensioners/family pensioners and their dependents:

1. 20% discounts on CGHS Chandigarh rates on the Procedures/packages/treatment/diseases covered under CGHS.
2. Agree to provider all In-house services as per CGHS rates.
3. If procedures are not on CGHS rate list then charges as per hospital rates.
4. OPD charges as per CGHS rate list.
5. 15% discount on medicines granted.
6. General wards, Semi private wards and Private wards all are charges as per CGHS rates.

The Concessions given by the Hospital are subject to the following conditions:-

- i. PSPCL will sign no agreement with the hospital in this regard.
- ii. PSPCL will only circulate the offer of concessions given by the hospital and will not give any clarification or attend any complaint in this regard.
- iii. PSPCL will not bind any employee/pensioner/family pensioners and their dependents to get the treatment from their hospital.
- iv. Payment of OPD and IPD will be made directly to the hospital by the employee/ pensioner and their dependents. However the employee/ pensioner/family pensioner, if entitled to get reimbursement, can claim re-imburement from PSPCL as per prevailing instructions and at the rates/ amount verified by the Health department wherever applicable.
- v. PSPCL will not give any surety regarding payment by its employees/pensioners and their dependents to the hospital.
