- iii) PSPCL is not binding any employee/pensioner/family pensioner and their dependents to get the treatment from their Hospital.
- iv) Payment of OPD and IPD will be made directly to the hospital by the employee/pensioner/family pensioner and their dependents. However the employee/pensioner/family pensioner, if entitled to get reimbursement, can claim re-imburement from PSPCL as per prevailing instructions at the rates/ amount verified by the Health department wherever applicable.
- v) PSPCL will not give any surety regarding payment by its employees/ pensioners/ family pensioner and their dependents to the hospital.
