**Subject: Regarding concessions offered by the Simrita Nursing Home, Rajpura to the PSPCL employees, Pensioners and their dependents & families.**

The Simrita Hospital, Dalima Vihar, Rajpura has agreed to provide the following concessions to the PSPCL employee, pensioners and their dependents & families:

1. **OPD:** All OPD Consultations will be charged @ Rs.135/- and a discount of 10-15% will be provided on OPD Medicine Bill.
2. **Lab & Diagnostics:** A discount of 20% on Lab and Radiological investigations being done in the Hospital.
3. **IPD:** All procedures will be charged at CGHS rates. For procedures not covered under CGHS rate List, the Hospital will provide 20% discount on the final Hospital bill.
4. **Ambulance Service:** Free Ambulance services to PSPCL Employees in Rajpura City.

The discounts/concessions given by the hospital are subject to the following conditions:-


- i) PSPCL will sign no agreement with the hospital in this regard.
- ii) PSPCL will only circulate the offer of concessions given by the hospital and will not give any clarification or attend any complaint in this regard.
- iii) PSPCL will not bind any employees, pensioners and their dependents & families to get the treatment from their hospital.
- iv) Payment of OPD and IPD will be made directly to the hospital by the employees, pensioners and their dependents & families. However the employee/ pensioner/family pensioner, if entitled to get reimbursement, can claim re-imburement from PSPCL as per prevailing instructions and at the rates/ amount verified by the Health department wherever applicable.
- v) The beneficiaries i.e. PSPCL employee/pensioners and their dependents & families are advised to equip themselves with full knowledge of hospital rules/rates/conditions before availing services as PSPCL is only circulating the offer of discounts given by the hospital.
- vi) PSPCL will not give any surety regarding payment by its employees, pensioners and their dependents & families to the hospital.
