h. The promotion of the official(s) is subject to the condition that on promotion he/she shall not

be entitled to seniority on promoted rank over those who are otherwise senior to him /her but whose cases are not complete for want of certain formalities and the sequence of order may not be considered as seniority.

i. As per Secretary/PSEB (now PSPCL) Memo No. 87442/88077/ENG 1/L-06 dated 2.8.2006 on promotion/transfer, the official should first join at his place of posting before his application for further adjustment is entertained.
